

Minutes of the Meeting of Mayfield Parish Council
Wednesday 8th March 2017 at 7.30pm in the Memorial Hall, Mayfield

- 28/17 Approval of the Minutes of the meeting on Wednesday 1st February 2017.**
The Minutes were approved by all Cllrs, and signed off by the Chair, Cllr Turner.
- 29/17 In Attendance**
Cllrs Amy, Edge, Moss, Parker, Turner and Watson were all in attendance. Cllr Cook sent his apologies.
- 30/17 Declarations of Interest**
There were no declarations of interest from Cllrs.
- 31/17 Public Participation**
Pat Smith was in attendance. Pat asked if the Parish Council was involved with the Mayfield Charities (Princes and Frosts Charities) as it was his understanding that the Parish Council appointed the Trustees, and should receive annual updates.

- 33/17 Highways & Rights of Way**
Complaints logged with Highways at Staffordshire County Council (SCC)
4057435 - The pothole at the bottom of Bridge Hill has been filled in.

Complaints to be logged with Highways, Staffordshire County Council
1) Light plate hanging off lamppost on East View.
2) Crumbling kerbstones, outside Nos 1 and 2, Mayfield Avenue.
3) Light out at bottom of Moorlands Drive, on left hand, facing up the road.
4) Cllrs Turner and Parker have received complaints regarding lorries, turning into Ashlea Drive and Moorlands Drive, reversing out onto the Main Road (B5032). Lorries are holding up traffic, including the school bus, damaging the grass verges and have the potential to cause an accident. It is believed that the lorries are going to Mayfield Mill.
Action: Clerk to report complaints to Highways, and follow up on 4064848, Old Bank
Action: Clerk to request clarification re management of grass verges e.g. ESBC or SCC
- Dog Fouling**
The bin at the park on Moorland Drive cannot be resited by ESBC Waste Management as the park is managed by ESBC Parks and Landscapes. However, Waste Management have placed a bin on the lamppost below the park. Waste Management will keep an eye on the bins along the main road and assess whether they need resiting.
Action: Clerk to follow up PC's request to provide a larger bin at the bus stop on Sycamore Drive and for a bin opposite the Pumping Station on Slack Lane.
- Free Dog Poo Bags**
The Clerk provided the example of Breaston PC who offer free poo bags to parishioners. Cllrs are still interested in the idea.
Action: Cllr Amy to look at the cost of bag holders for potential placement on bins etc.
Action: Cllr Turner to cost providing free poo bags and email Cllrs with the price
- Rights of Way**
Cllr Amy asked who is responsible for cutting back the holly bush / trees overhanging Mayfield 21 footpath. The Clerk confirmed that it is the relevant homeowner on The Park.
Action: Clerk to write to the homeowner

 Dave is still working on the Memorial Gardens.
Action: Clerk to chase Dave for signed copy of invoice, to be sent to SCC for Lengthman spend refund
 Cllr Parker reported that the bus stops are full of leaves / debris.

 Cllrs asked for the bank/hedge between Briarways and The Old Post Office to be cleared.
